TO: ALL PASC MEMBERS  
Re: PASC Accounting Procedures (1969, 1988 and 1996)  
Wage Index Adjustment

In accordance with the terms of the referenced Accounting Procedures, the overhead rates chargeable under the following subclauses shall be adjusted as of the first day of July each year. (Please note that in the 1988 and 1996 Accounting Procedures this provision is an election. Therefore, in order for overhead rates to be automatically adjusted by the wage index factor, the parties need to have made an affirmative election with regard to this provision.)

1969 Accounting Procedure: Subclause 314(b)(1)  
1988 Accounting Procedure: Subclauses 302(d)(2) and 302(d)(3)  
1996 Accounting Procedure: Subclauses 302(e)(2) and 302(e)(3)

The adjustment shall be computed by multiplying the rate in use by the percentage increase or decrease in the average weekly wage and salary of the Canadian Petroleum and Natural Gas Industry for the last calendar year next preceding such last calendar year as reported by Statistics Canada.

The computation of the 2006 adjustment has been determined as follows:

2006 Monthly Average	\$1,428.49
2005 Monthly Average	<u>\$1,356.29</u>
Increase:	<u>\$72.20</u>
Percentage <u>Increase</u> :	5.32%

Effective July 1, 2007, overhead rates may be increased by 5.32%, subject to the elections described above.
